Operating Authority in Canada: Information

In this document you will learn about opening authority for a trucking company doing business across the border in Canada. To simplify much of the details, a company that plans to haul loads to and/or from Canada needs an operating authority in Canada. Our consulting firm is here to help you through the entire process.

OPENING AUTHORITY PROCESS

In order to open authority for legal, commercial travel to Canada a company must first establish what sort of authority needs to be opened. The authority allows you to enter and exit Canada with or without a load. The short questionnaire in the application will allow us to apply for all the necessary documentation to open your authority including: CVOR, CARRIER CODE, SCAC, PAPS & PARS, ACE E-MANIFEST, ACI E-MANIFEST. You can fax, email or bring the application to our office in person. We charge \$800 for the authority, plus the cost of PARS and PAPS stickers.
